Sealed bids for the **Taxiway Rehabilitation** will be received by the Owner by e-mail to Ray Detor, Jr. (Owner, rsdjr1400@aol.com), **and** to Mary Kay Genthner (Passero, mkgenthner@passero.com), date and time stamped **at or prior to 3:00 PM, Thursday, May 28, 2020**, and thereby, at said time, be publicly opened and read aloud via **GoTo Meetings** accessible by **phone (312) 757-3121**, with **Access Code 177-901-717**. Bids shall be submitted electronically per above, with the e-mail subject heading clearly marked "**LeRoy Airport - Taxiway Rehabilitation**".

The **Base Bid A** project generally consists of crack repair, application of two (2) coats of pavement sealer, and pavement markings, including associated pavement preparation work, for the full length parallel taxiway (approximately 3,500' x 25'). The **Base Bid B** Project generally consists of milling, crack repair on milled surface, asphalt overlay, and pavement markings, including associated pavement preparation work, for an approximately 2,700' length by 25' width of asphalt taxiway pavement. Prevailing wage rates apply. Contractors must be bonded and insured to the level indicated in the Contract Documents. A Federal DBE participation goal is included in the Contract. The project is not sales tax exempt. **Bidders must include applicable sales tax in submitted bids.**

A complete set of Bid Documents, consisting of the General Provisions, Special Provisions, FAA AC 150/5370-2G, Technical Specifications, Bid, Agreement and Contract Drawings, will be available on **Friday, May 1, 2020**, and may be obtained from **Passero Associates at www.passero.com under the 'BID' tab** for a fee of **\$25.00 (Non-refundable)**.
